#### **New Business**

- ➤ Capital Improvement Plan (CIP) Subcommittee Recommendations- Mr. Hiland gave an overview of CIP meeting held with the Select board on February 3rd. The collaborative meeting discussed the future capital improvements needed for the Town's buildings, cemeteries, roads and bridges. There were two (2) recommendations made to be presented to the Planning Board for discussion. The recommendations are as follows;
  - 1. To recommend to proposed amount of \$25,000.00 to the Select Board to be added to the Highway Capital/ Reconstruction Fund.
  - 2. To recommend the proposed amount of \$5,000.00 to the Select Board to be added to the Cemetery Expendable Trust Fund

Further discussion was held regarding each recommendation and how the proposed amounts were determined. There was also a brief discussion regarding the possible future needs of school bus transportation.

- ➤ There was a discussion held regarding the 2016 Budget proposed to the Select Board and it was advised that the Technical Consultant line item was dropped from \$1000.00 to \$500.00.
- ➤ There was a discussion held regarding the Legislative Bulletins produced by NHMA, as they do keep updates on the House Bills being presented. Mr. Hiland will keep an eye on what may be presented in the future.
